METHODOLOGY & DESIGN

METHODOLOGY. OBJECTIVES



The main goal of the research project is a structured understanding of the public's perception of the phenomenon of domestic violence.

We have measured:

- **A. Elements of perception + knowledge about the topic** spontaneous elements, the level of public information, the public "definition" of the phenomenon of domestic violence, etc.
- **B. Public attitude towards domestic violence** investigated by degrees / typologies of the phenomenon.
- C. Elements of actual impact perceived incidence of the phenomenon, personal or reported (mediated) behavioral components





METHODOLOGY. DESIGN



- Opinion poll, structured interview, conducted face to face, by interview operators, based on a questionnaire implemented on the electronic platform (CAPI).
- Total sample, N=1112
- Sample characteristics age 18+; quotas by age, gender, urban + rural
- At the level of the entire sample, we have a sampling error of maximum 2.9% for a confidence interval of 95%
- The selection of participants was done using a randomization step within the public space









- For most Romanians, domestic violence is primarily a direct physical aggression.
- The more the components of violence (comprehensively defined, multi-faceted) move away from the physical and closer to the symbolic e.g., restrictions on freedoms, deprivation of economic means etc. the laxer the public tends to be with their inclusion in the phenomenon.



- For example,
 - 10% of the public believes that economic deprivation (rather) is NOT an expression of domestic violence.
 - OR

10% of the public believe that monitoring or surveilling their partner's intimacy (rather) is NOT an expression of domestic violence.



- Opinions about the place of domestic violence in the couple are obviously marked by the awareness of the social desirability of what is "the proper" reaction to the phenomenon = intolerance to the phenomenon, defined simplistically, is explicitly firm;
 - 97% of people consider physical violence to be completely unacceptable
 - BUT at the same time:
 - 52% of people agree that tense situations in the couple, including physical, are understandable if their partners are able, later, to forgive each other

OR

60% of people believe that traditionally in Romania, the man leads the family and sometimes he needs to be firmer in doing so

Obviously, the above do not necessarily represent, each separately, acts of domestic violence, but together they reveal a mental construct that, in some situations, closely correlates with the phenomenon.





We could conclude that there is a dissonance between:

The social complexity of the domestic violence phenomenon – nuanced, with multiple facets that incorporate including non-physical manifestations fueled by social media or modern digital technologies

AND respectively

The central perception of the public, which is reductionist, simplistic – strongly condemns physical assaults, which are considered the essence of the definition of domestic violence but tends to be more lenient with other types of abuse.





- Only 79% of survey participants believe domestic violence is unacceptable AND should also be punishable by law.
- This opinion is significantly stronger for women (+11%) than for men
- At the same time, the urban area is more intransigent (+4%) than the rural area on the same topic
- 90% of participants believe that the Police should intervene in cases of domestic violence



- Tough laws and education are considered to be the most important in preventing the phenomenon
- Tough laws and PUBLIC INFORMATION are considered the most important mechanisms for REDUCING the phenomenon
- Alcohol abuse is considered the biggest cause of domestic violence (35%), followed by infidelity (28%)
- Almost 40% of people do not know about the existence of a law that punishes domestic violence



70% of respondents say they have heard of domestic violence cases in the past year
 (in 40% the main cause was drinking)

Of the 70%

About 75% did nothing either because it wasn't their business/or because it was late

- •About 18% made recommendations or gave advice to the victim
- Only 4% notified authorities

10% of respondents say they have been or are subject to some type of domestic abuse

46% of them are or have been victims of physical assault












Incompatible elements with a good romantic relationship





DOMESTIC VIOLENCE. SPONTANEOUS DEFINITION



For over half (54%) of the respondents, domestic violence is **primarily** represented by **physical acts** of violence: bruising, kicking, etc.

Only **16%** of participants spontaneously associate domestic violence with **any kind of abuse** – regardless of its nature.

All mentioned facets represent forms of domestic violence, according to most respondents.

The maximum perception is found in **physical violence** of any kind, where **90%** perceive it as domestic violence, in any situation.

The minimum perception is found in **economic deprivation** – but even here, almost **61%** perceive this facet as domestic violence.



YES, definitely, in any situation



Among individuals of female gender, the perception regarding the facets of domestic violence is less indulgent.

The maximum difference is found in the **restriction of free movement** of any kind, where **69%** of women perceive it as domestic violence in any situation, compared to only 60% of men.

ASPECTS OF LIFE. FACETS OF DOMESTIC VIOLENCE. DIFFERENCES BETWEEN LIVING

ENVIRONMENT



When comparing the urban and rural environments, the differences are not spectacular.

The maximum difference is found in **neglecting rights**, where **70%** of those in **urban areas** perceive it as domestic violence in any situation, compared to only **65%** in **rural areas**.

Physical violence is completely unacceptable behavior in a couple: 97% (78% completely agree, 19% somewhat agree) of respondents agree with this statement.

On the other hand, some situations of physical conflict can be tolerated if there is forgiveness: 52% agree (20% completely agree, 32% **somewhat** agree)



DOMESTIC VIOLENCE. PERCEPTIONS. DIFFERENCES BETWEEN GENDERS



For men, the perception that they **lead the family** is more pronounced than among women: **67% agree**, compared to just **54%.**

Another significant difference concerns the tolerance of situations of physical conflict: **55% agree**, compared to just **49%** among women.







DOMESTIC VIOLENCE DIRECTED AGAINST WOMEN




More than three-quarters of respondents believe that **domestic violence directed against women** should be punished by law.


At the same time, approximately 10% believe that it is acceptable in certain situations.

DOMESTIC VIOLENCE DIRECTED AGAINST WOMEN. DIFFERENCES






Men have a slightly more lenient perception regarding the punishment of domestic violence directed against women: 73% agree, compared to 84% among women.

Individuals from **urban** areas are more uncompromising regarding the **punishment of domestic violence directed against women**: **81% agree**, compared to **77%** among those from **rural** areas.

DOMESTIC VIOLENCE. INTERVENTION




Nearly all respondents (90%) believe that the police should intervene in cases of domestic violence.

Important responsibilities are also found for the **Social Assistance Departments** (42%) and **close relatives** (37%).

DOMESTIC VIOLENCE. PREVENTION




The majority of respondents (60%) believe that **prevention** should be achieved through **special and severe laws**.

Other important prevention mechanisms are education (in schools 43%, at home 43%) and permanent information of the public (40%).

DOMESTIC VIOLENCE. REDUCTION




The majority of respondents (60%) believe that **reduction** should be achieved through **special and severe laws**.

Other important prevention mechanisms are permanent information of the public (40%) and education (in schools 35%, at home 34%).

DOMESTIC VIOLENCE. CAUSES



The main cause of domestic violence is considered to be alcohol consumption (35%).

In second place, we find **infidelity** / **jealousy** (28%), and in third place, **financial problems** (16%).




DOMESTIC VIOLENCE. LAWS

The system should drastically punish cases of physical domestic violence from the first offense - as any serious crime

law should be more

If it happens the first time and the aggressor regrets it, then the understanding and recommend only psychological counseling



Nearly three-quarters (73%) believe that the system should drastically punish cases of domestic violence **from the first offense** – as any serious crime.



DOMESTIC VIOLENCE. LAWS. DIFFERENCES



Men have a slightly more lenient perception regarding the punishment from the first offense of domestic violence directed against women: 68% agree, compared to 77% among women.


Individuals from the **rural** areas are more uncompromising regarding the **punishment from the first offense of domestic violence directed against women: 75% agree**, compared to **71%** among those from **urban** areas.





The majority of respondents (62%) are aware that there is currently a law regarding domestic violence between spouses and life partners.

DOMESTIC VIOLENCE. ACQUAINTANCES - CAUSES





More than two-thirds (70%) state that they have heard in the last year about cases of domestic violence among acquaintances.


The main cause of domestic violence was alcohol (40%), followed by infidelity / jealousy (27%).





More than two-thirds (70%) state that they have heard in the last year about cases of domestic violence among acquaintances.










Among them, approximately 46% claim they are or have been victims of physical aggression.






DOMESTIC VIOLENCE. ACTIONS — CLOSE ONES VS. STRANGERS





If they were to hear about a case of domestic violence among close ones, approximately one-third (37%) of respondents claim they would notify the police / authorities.

About 10% say they wouldn't get involved, while another 14% prefer not to respond.

If they were to hear about a case of domestic violence involving strangers, only 14% of respondents claim they would notify the police / authorities.

Approximately **7%** say they **wouldn't get involved**, while nearly three-quarters (**72%**) **prefer not to respond**.






DOMESTIC VIOLENCE. WOMEN - VICTIMS AT LEAST ONCE VS. REPEATEDLY





Nearly three-quarters of respondents (72%) believe that at least one out of two women has experienced domestic violence at least once. The average estimated percentage is 55%, and the median value is 60%.

More than three-quarters of respondents (83%) believe that less than half of women are trapped in relationships where they are repeatedly victims of domestic violence. The average estimated percentage is 32%, and the median values is 30%.







DOMESTIC VIOLENCE. WOMEN - VICTIMS AT LEAST ONCE. COMPARISONS





More than three-quarters (77%) believe that at least one out of two women has experienced domestic violence at least once. For men, the value is lower: 65%. The average estimated percentage is 58% for women and 52% for men, and the median value is 60% for women and 50% for men.


Approximately three-quarters of those in urban areas (72%) believe that at least one out of two women has experienced domestic violence at least once. For rural areas, the value is identical: 72%. The average estimated percentage is 54% for urban and 56% for rural, and the median value is 60%, for respondents from both areas.





Q: In your opinion, what percentage of women in Romania have experienced domestic violence at least once? [open, single]

DOMESTIC VIOLENCE. WOMEN - VICTIMS REPEATEDLY. COMPARISONS








Almost all those in **urban areas** (85%) believe that **less than half of women** are trapped in relationships where they are repeatedly victims of domestic violence. For those in **rural areas**, the value is lower: **79%**. The **average** estimated percentage is **32%** for **urban** and **33%** for **rural**, and the **median** value is identical for both areas: **30%**.

DOMESTIC VIOLENCE. PROBLEM IN ROMANIA



Domestic violence is perceived as the **most significant issue in Romania**: 91% of respondents perceive it this way. Approximately **half** (50%) of respondents believe it is a very significant problem. Following closely are family violence against children (89%) and violence associated with thefts and robberies (83%).











DEMOGRAPHICS. OCCUPATION AND HH INCOME









DEMOGRAPHICS. MARITAL STATUS, HH MEMBERS AND KIDS




